To Book a Site:

- Complete a Trade Space Application Form with all required information.
- Return to the Trade Co-ordinator via email at belingenshowtrade@gmail.com
- Attach public liability insurance certificate of currency with application form.
- Include additional \$30.00 fee if using Society's insurance. Submission of the Trade Space Application Form consents to understanding & agreement to comply with the conditions set by the Society.
- Include cheque or receipt no. for EFT transactions with application. **Applications without payment will NOT be booked.** Bellinger River Agricultural Society reserves the right to refuse a trade application and will refund any monies received.
- Allocated space must include tent pegs, guy ropes, awnings and tow bars.
- Each stall holder will be issued with 2 complimentary 2 day passes only for participating trade vendor operators.

Arriving at the Show

- Entry and exit to the grounds is via the Hammond Street gate only
- Report to the Trade Co-ordinator on arrival.
- All non-required vehicles must leave the trade space area by 8.00am both Saturday and Sunday.
- No vehicles may move around the trade site during opening hours of the Show due to the number of people and animals on site.
- Please observe all of parking and traffic directions
- Electrical equipment is to be fitted with earth leakage circuit breakers.
- All electrical leads, tools and appliances to have been inspected and tagged by a licensed electrical contractor.
- Cables cannot be laid on the ground in areas accessible to the public.
- Sites cannot be sublet.
- Evidence of compliance may be requested by OHS inspector on site
